#### ORDER:

The Project Director, Tamil Nadu Health Systems Project has stated that as per tender document for the implementation of Chief Minister's Comprehensive Health Insurance Scheme orphans residing in any registered/ unregistered organization can be given a single card and the Government will pay premium.

2. The Project Director, Tamil Nadu Health Systems Project has stated that the Commissioner of Social Defence and Commissioner of Social Welfare have forwarded the details of Orphan Children / Orphans / Senior citizens living in homes orphanage etc., for enrolment under Chief Minister's Comprehensive Health Insurance Scheme as requested for by him. In the tender document the eligibility criteria for the beneficiaries of the scheme has been defined i.e. for all Tamil Nadu resident families annual family income is less than Rs.72,000/-. Hence it is sufficient to produce family card and income certificate issued by the Village Administrative Officer concerned for enrolment under Chief Minister's Comprehensive Health Insurance Scheme.

3. The Project Director, Tamil Nadu Health Systems Project has stated that in the case of orphans etc., they will not be having family card / income. The tender condition is also silent about the production of documents by orphans and there is no specific mention for submitting the family card and income certificate by them for enrollment.

4. The Project Director, Tamil Nadu Health Systems Project has stated that it is therefore proposed to enroll the orphans residing in any registered organization /

registered with the District Child Protection Officers (DCPO) without family card and income certificate and United India Insurance Company have been instructed to enroll the orphans etc., as per the details shared by the Social Defence Department and Social Welfare Department without family card and income certificate.

5. The Project Director, Tamil Nadu Health Systems Project has requested the Government to issue necessary orders to enroll orphans under Chief Minister's Comprehensive Health Insurance Scheme, residing in any registered organization / registered with the District Child Protection Officers (DCPO) without family card and income certificate and also to ratify the action for having permitted UIIC to enroll orphans without the above documents.

6. The Government after careful examination of the proposal of the Project Director, Tamil Nadu Health Systems Project have decided to accept the same and issue following orders :-

- i. The action of the Project Director, Tamil Nadu Health Systems Project is ratified for having been permitted UIIC to enroll orphans as per the details shared by the Social Defence Department and Social Welfare Department without the family card and income certificate in anticipation of the Government orders.
- ii. The Project Director, Tamil Nadu Health Systems Project is permitted to enroll orphans under Chief Minister's Comprehensive Health Insurance Scheme, residing in any registered organization / registered with the District Child Protection Officers (DCPO) without family card and income certificate.


