



**Guidelines for the Identification of beneficiaries under Uzhavar
Padhukappu Thittam for enrolment under CMCHIS**

(I) Eligibility

- (i) All the members of the Uzhavar Padhukappu Thittam are eligible in this scheme.
- (ii) There is no income ceiling limit to these beneficiaries.

(II) Identification

- (i) The beneficiaries under Uzhavar Padhukappu Thittam should be identified and certified by the VAO concerned.

(III) Verification

- (i) The newly identified beneficiaries should be verified with the existing CMCHIS data for de-duplication.

(IV) Enrolment


- (i) After the process of de-duplication enrolment is done at the District Kiosk.
- (ii) The insurance card should be issued to the beneficiary at District Kiosk through online printing.
- (iii) Monthly report on enrolment should be sent to TNHSP.


(V) Distribution of cards

- (i) Printed cards to be issued on the spot from the District Kiosk.
