Chief Minister's Comprehensive Health Insurance Scheme – To exempt from deduction of 28% Corpus Fund / IEC fund from Chief Minister's Comprehensive Health Insurance Scheme claims for certain procedures – Orders – Issued.

ORDER:

In the Government Order first read above, Orders were issued granting permission to exempt from deduction of 28% of corpus fund from Chief Minister's Comprehensive Health Insurance Scheme claims for the following procedures:

1. CM0358 Hypopituitarism package
2. Maintenance Hemodialysis
3. All valve replacement surgeries
4. All On Pump CABG surgeries done under CTS
5. ASD repair
6. VSD repair
7. Permanent Pacemaker Implantation.

2. In the letter second read above, the Project Director, Tamil Nadu Health Systems Project has stated that all District Differently Abled Departments have been empanelled under Chief Minister's Comprehensive Health Insurance Scheme for providing functional prosthesis under Chief Minister's Comprehensive Health Insurance Scheme for the welfare of differently abled beneficiaries. The State Commissioner, Differently Abled Department has stated that to exempt the deduction of 28% corpus fund for this package. The Project Director, Tamil Nadu Health Systems Project has requested to examine the feasibility of meeting the difference of cost from their budget provision to the State Commissioner for Differently Abled Department.

3. The Project Director, Tamil Nadu Health Systems Project has further stated that a communication has been received from the Commissioner, Differently Abled department that there has been no necessity for the department to accommodate the 28% corpus fund detected under Chief Minister's Comprehensive Health Insurance Scheme from their budget provision and requested to exempt the deduction of 28%

corpus fund for the package CM0821 – IA to CM0821 -IL. The Regional Manager Endolite stated that they were empanelled under Chief Minister's Comprehensive Health Insurance Scheme for fitments of modular artificial limbs to the beneficiaries from Tamil Nadu through DDAWO officials and hospitals through which they have fitted 344 artificial limbs so far at the cost of Rs.1,95,42,810/-. But, the payment received was of only Rs.91,43, 857/- i.e. 46%. In addition, 28% is being deducted from the actual quoted value and hence they have requested to look in to this matter for consideration.

4. The Project Director, Tamil Nadu Health Systems Project has stated that communication was received from the Professor and HOD, Department of Orthopedics-PMR stating that on verification of the passbook of ortho-PMR department, the credited amount for functional prosthesis under Chief Minister's Comprehensive Health Insurance Scheme was only 72% of the approved amount. The 72% of amount will not be sufficient for supplying to vendors and unless 100% of amount remitted, the services cannot be fulfilled for the differently abled beneficiaries.

5. The Project Director, Tamil Nadu Health Systems Project has stated that the package is only for assessing, procuring and fitting the Functional prosthesis to the amputees and differently abled. The procuring cost of the prosthesis was not able to be met out from the package, since they deduct 28% for corpus fund, which makes only 72% of our fund available for prosthesis purchase effectively. The 72% of the total cost of the package CM0821 will not be sufficient for them to render Amputation of Any Site / Any Cause with Custom Made Prosthesis service under Chief Minister's Comprehensive Health Insurance Scheme.

6. The Project Director, Tamil Nadu Health Systems Project has therefore requested the Government to exempt the deduction of corpus fund (already deducted and to be deducted) from Chief Minister's Comprehensive Health Insurance Scheme claims for the procedure CM0821 AMPUTATION OF ANY SITE / ANY CAUSE WITH CUSTOM MADE PROSTHESIS (EXCEPT FINGERS, TOES AND SMALL JOINTS).

7. The Government after careful examination have decided to accept the request of the Project Director, Tamil Nadu Health Systems Project. Accordingly, the Government grant permission to exempt the deduction of corpus fund (already deducted and to be deducted) from Chief Minister's Comprehensive Health Insurance Scheme claims for the procedure CM0821 AMPUTATION OF ANY SITE / ANY CAUSE WITH CUSTOM MADE PROSTHESIS (EXCEPT FINGERS, TOES AND SMALL JOINTS).

8. This order issues with the concurrence of the Finance Department vide its U.O.No.49079/Health-II/2019, dated: 17.02.2020.
