ORDER:

The Project Director, Tamil Nadu Health Systems Project in the reference read above has submitted the proposal to Government for settlement of RT-PCR testing charges to non Chief Minister's Comprehensive Health Insurance Scheme beneficiaries as detailed below:-

- i. He permitted UIIC to make payment of the Public Health authorities referred Non-Chief Minister's Comprehensive Health Insurance Scheme beneficiaries samples (RT-PCR testing) in the lines of Chief Minister's Comprehensive Health Insurance Scheme beneficiaries samples in anticipation of the Government orders. Ratification of Project Director, Tamil Nadu Health Systems Project for having been allowed payment by UIIC is under consideration of the Government.
- ii. Based on the decision taken in the Core Committee dated 30.07.2020, UIIC have been permitted to continue the practice of testing Non- Chief Minister's Comprehensive Health Insurance Scheme beneficiaries like in the lines of Chief Minister's Comprehensive Health Insurance Scheme beneficiaries pending issue of order from the Government.
- iii. During the meeting held regarding funds sanction and fund availability for Covid-19 Relief Measures, under the Chairmanship of the Chief Secretary on 17.07.2020, it was decided that the funds required for Covid-19 testing for non Chief Minister's Comprehensive Health Insurance Scheme beneficiaries referred by the Government, have to be met from the State Funds.
- iv. During the core committee meeting held on 11.09.2020 under the Chairmanship of Managing Director, Tamil Nadu Medical Services Corporation, it was decided that the payment for 65% of the total tests for RT-PCR testing except Airport and Toll samples, based on the percentage of Chief Minister's Comprehensive Health Insurance Scheme

and Non-Chief Minister's Comprehensive Health Insurance Scheme beneficiary population in the State of Tamil Nadu will be borne by UIIC and for remaining 35%, the funds will be allotted by the State Government to UIIC through Tamil Nadu Health Systems Project.

- v. The details for the payment to Non-Chief Minister's Comprehensive Health Insurance Scheme beneficiaries for RT-PCR Testing of patients affected by COVID-19 are detailed below:-

After careful examination of the proposal of the Project Director, Tamil Nadu Health Systems Project, the Government have decided to accept the same and accord sanction for a sum of Rs. 101,84,05,570/- (Rupees One hundred and one crore eighty four lakh five thousand five seventy only) towards the settlement of RT-PCR testing charges to Non-Chief Minister's Comprehensive Health Insurance Scheme beneficiaries.
